

Explicit Consent Statement and Commercial Electronic Message (İYS) Consent

Pursuant to Law No. 6698 on the Protection of Personal Data (“KVKK”), I hereby acknowledge that I have been informed by PİYALEPAŞA GAYRİMENKUL GELİŞTİRME YATIRIMI ve TİCARET A.Ş. (“POLAT”) and Atlas Portföy Yönetimi A.Ş. (“ATLAS PORTFÖY”) about (i) the purposes for which my personal data will be processed, (ii) the recipients to whom and the purposes for which the processed data may be transferred, (iii) the method and legal basis of the collection of personal data, and (iv) my rights under Article 11 of the KVKK.

In summary, I freely and explicitly consent to POLAT and to ATLAS PORTFÖY (to which my personal data are lawfully transferred) carrying out the promotion of all relevant and related products and services—particularly the ATLAS PORTFÖY YÖNETİMİ A.Ş. POLAT BİRİNCİ PROJE GAYRİMENKUL YATIRIM FONU—and sending me advertising notifications via various digital communication channels (e-mail, SMS, etc.) and by telephone in order to inform me about campaigns and promotions. I acknowledge that I have read and understood the privacy notice, and I accept, declare and undertake the foregoing.

Right to Refuse and How to Exercise

Your explicit consent for the above-mentioned processing activities and for the sending of commercial electronic messages remains valid until you exercise your right to refuse. Exercising your right to refuse only prevents the sending of commercial electronic messages based on your explicit consent—and thus the processing of your personal data for that purpose. It does not affect the validity of any legal transaction between you and the Data Controller or recipient groups, nor does it preclude the application of other relevant provisions set out in the Law on the Regulation of Electronic Commerce (Law No. 6563) and its secondary legislation.

Your refusal request will take effect promptly upon receipt by our Company when you send an SMS stating "POLAT RET" to 7889, or when you follow the opt-out instructions provided in each message.
